It is that time of year again where trusts throughout the country are gearing up for a busy summer of fieldwork. NBFT are no exception with an ambitious monitoring plan already underway. It is hoped that juvenile surveys will be carried out on over 150 sites throughout the Ness and Beaully Catchments in the coming months. Coastal burn surveys have been completed. These burns are thought to be important habitats for

sea trout and early indications suggest good trout numbers along with salmon, eels, lampreys and flounders.

## Scottish Mink Initiative

The Scottish Mink Initiative aims to remove breeding American mink from north Scotland and covers an area of 20,000 km<sup>2</sup>.

Its that time of year again, Kitts will now be leaving their home nests and dispersing. Numer-

ous sightings have occurred recently with a family of 9 seen on the Ness. We have had two captures so far, one on the Beaulieu catchment and one on the Ness catchment.

Please contact the trust if you have seen a suspected mink whether

alive or dead.

If you would like to volunteer to monitor a raft then we will provide all equipment. Please contact the trust office.

## Moray Firth Trout Initiative

The trust carried out a netting operation at the mouth of the River Beaulieu in early June. This was a new site which presented us with very different conditions to previous sites within the firth. After a number of

practice runs the net was fishing great. Although no fish were caught, probably as a result of timing rather than our technique we did catch a number of salmon parr.

It is hoped to try this site

again in July/August in the hope that the Sea Trout will be running. If you would like to get involved then please contact the trust office.

# Scale sampling.

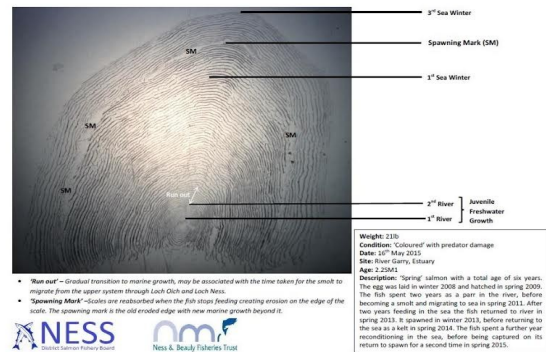
2014 saw the introduction of a comprehensive salmon scale sampling and ageing programme on the Ness Catchment, this was extended to the Beauly catchment in 2015. The ageing of fish is an important fisheries management tool.

A total of 46 Ness and 22 Beauly salmon scale samples have been read so far this season (a number of the Beauly samples were historical). This is a really good start and is likely to

result in a robust scale sample this year (75 in total submitted for the season last year).

Of particular interest was a 21lb coloured 'spring' salmon caught and released on the 16<sup>th</sup> May 2015 at the River Garry estuary (Ness system) (see attached photo). This fish was found to be a repeat spawner, which spent two years in freshwater followed by two years in the sea before returning to spawn. The fish survived

the spawning process and returned to the sea as a kelt. It spent another year at sea before being caught on its return to spawn for



## Pearls in Peril Life + Project

Pearls in Peril is a national project aimed at conserving existing populations of the Freshwater Pearl Mussel (*Margaritifera margaritifera*).

After our successful encystment the trust revisited the sites to monitor glochidial loadings on the fish we encysted. This involved elec-

trofishing and looking at the fish gills for evidence of glochidia. Only one fish was carrying glochidia but at a high level so it was assumed that it was one of last years encysted fish.

Due to the habits of juvenile trout and salmon this was always going to be difficult...the proverbial needle in a haystack

but it was met with some success. We also checked on the naturally encysted fish to try and ascertain when glochidia may drop off. Fish were still carrying glochidia in June which is later than in West Coast rivers.

In addition we have visited a number of schools in the area

## Tagging

Good numbers of salmon are also being tagged throughout the Ness and Beauly systems. A number of recaptures have been reported. Angus Mackenzie caught a 'spring' salmon from the vicinity of the River Moriston estuary on Saturday 9<sup>th</sup> May 2015. The fish was found to be carrying or-

ange external anchor tag number 77.

Our records indicate that this fish had been caught and released by Angus MacGruer fishing the fly in the River Oich estuary earlier in the week on Monday the 4<sup>th</sup> May 2015. Mr Mackenzie reported that, even on its second capture, the fish was very 'fresh and

frisky' showing no signs of being caught a few days before. The results of our tagging programme to date have proved to be extremely interesting.

Many thanks to Chris Blake for reporting his capture of a tagged salmon (Yellow 112) from Loch Ness on Sat-

The fish was originally caught on the 5<sup>th</sup> June 2015 as a 13lb 'fresh' fish from the bottom beat of Dochfour Fishing (tail of the Island) by Davy Stewart. If handled correctly fish do survive to continue their journey.

## Wild Fisheries Reform

A paper published by the Scottish Government on the 15<sup>th</sup> May 2015 confirmed their commitment to the reform of wild fisheries, which will result in a new management system designed to meet the challenges and opportunities of the 21st century. The paper also sets out the Government's response to the independent Wild Fisheries Review. It outlines the fundamental principles on which the new system will be built, and commits to developing a national wild fisheries strategy for the management of all freshwater and migratory fish species.

The wild fisheries paper includes a consultation which seeks views on a

number of broad policy options including the balance of functions between local and national levels, funding, science and skills, regulation and compliance and promoting access and opportunity and careers in fishing. **Licence Killing of Salmon** – On the 23<sup>rd</sup> July 2015, Scottish Ministers advertised their intention to create a licensing system and carcass tagging regime as well as a prohibition on the killing of salmon out-with estuary limits through regulations. This follows the public consultation earlier this year on the proposed conservation measures

to introduce a licensing system for the killing of any wild salmon in Scotland together with associated carcass tagging and baits and lures regulations.
